#### **PANTS**

Shoes must be dark in color, closed-toe, identified as slip-resistant and appropriate for standing for long periods of time.

#### **HAIR**

Hair must be clean and combed.

#### **TATTOOS**

No visible tattoos are allowed above the shoulders (excluding tattoos for natural looking cosmetic enhancements, such as eyebrow, lips, and eye liners).

#### PIERCINGS/JEWELRY

Two (2) sets of reasonable sized earrings may be worn in each ear lobe.
